







# **GUIDELINES FOR USAGE AND MAINTENANCE FOR AUTOMOTIVE BATTERIES:**

- 1. User need not open vent plugs.
- 2. The battery should be firmly secured in the cradle. Please ensure that the cable clamps are fit tightly and properly on the terminals. A loosely held battery, vibrates and bounces, causing damage to the container and plates.
- 3. Connections must be made in the right polarity.
- 4. The top of the battery must be kept clean and dry. Vaseline should be applied to cable clamps and terminals. Never apply grease. Terminal corrosion, dirt, and moisture cause loss of power and make the battery weak.
- 5. Get the fan belt, electrical wiring, alternator, regulator setting, and battery open circuit voltage checked regularly. A faulty electrical system will damage the battery.
- 6. The alternator charging voltage setting measured across the battery terminals must be maintained at 14.00 to 14.40 volts for the 12V system and 28 to 28.80 volts for the 24V System.
- 7. To get maximum life, it is advised that checks listed under point, no.5 be carried out once in every 3 months.
- 8. The Original Warranty will reduce the battery used in commercial applications and ensure that Fit is equivalent Capacity of OEM Fitment.

#### **AGM Recommended Vehicles:**

- Don't open the vent plugs of the battery if do so the warranty will void.

# **EFB For ISS (Idle Start Stop) vehicles:**

• Use the Amaron ONYX EFB Battery in The ISS vehicles where the OEM recommends the ISS/EFB battery.

# **SLI Applications:**

 Use the Amaron PRO/FLO/GO/BLACK SLI battery for starting, lighting, and Ignition applications.

## **Marine Application:**

· Use the Amaron Pearl Marine battery designed for marinea aplications only.

### Lawn & Garden Application:

· Use the Amaron GO U1 Battery for lawn & garden equipment applications only.

#### **CAUTION:**

- 1. Keep away from sparks, cigarettes, and open flame. These can cause explosions.
- Avoid metallic contact across the terminals as this can result in short circuit and sparking.
- 3. Do not use any Battery additives or dopes.
- 4. Keep the top surface of the Battery clean and dry. Always use a moist cotton cloth only. Never use a woollen/Silk or synthetic cloth, it can create spark.
- 5. Do not tilt the Battery in usage or transportation.
- 6. Keep out of reach of children.

#### **TERMS & CONDITIONS OF WARRANTY:**

- 1. The warranty period commences from the date of sale of the battery.
- 2. The warranty is limited to all defects arising from the use of faulty material or poor workmanship. Consequential liabilities will not be entertained.
- 3. In the event of any complaint, the battery must be returned to any nearby AMARON® Service location. Replaced / Recharged battery has to be collected from the same point.
- 4. The right to determine whether a battery needs free replacement rests with the AMARON® Distributor.
- 5. A defective battery arising out of free replacement will become the property of AMARON® Distributor and no scrap rebate will be given for it.
- 6. The warranty period will commence only from the date of sale of a new battery. Therefore, the date of replacement of the battery under warranty will not alter the warranty period.
- 7. All Liabilities under this warranty will cease if the battery is :
  - a. Transferred to a third party or to any other vehicle.
  - b. Used in any application other than that specified by the company.
  - c. Used in non-vehicular applications.
  - d. Damaged due to fitment of additional accessories other than the original fitment.
  - e. Out of warranty period.
  - f. Removal, obliteration, or alternation of the original QR code on the Battery and Warranty Card.
- 8. The warranty does not cover:
  - Damage to the battery caused by faulty electrical systems, improper handling, service by unauthorized dealers /auto electricians, willful abuse, and destruction by fire. collision, theft, or recharging.
  - · Breakage of container and cover
  - If battery-grade demineralized water is not added on time.
  - Found to have additives, dopes, or anything other than Battery grade de-mineralized water
- 9. The warranty booklet with QR Code intact must accompany all claims arising within the warranty period. Customers are deemed to have read, understood, and agreed to this condition at the time of purchase.
- 10. In the event of any particular Battery model being discontinued by us, we reserve the right to settle warranty replacement with an alternate Battery model.
